Proposal is needed for the remaining balance – Cllr Jeffry confirmed this was being actioned. It was noted the S106 monies have been retained in the parish and Ward Cllr O'Neill was thanked for his assistance in this matter.
- Changes to waste collection has resulted in the Community shop and Scouts being assessed as commercial. SGC has been asked to look at a subscription scheme and Ward Cllr O'Neill will chase for a response.
- Austerity is impacting SGC and although there is a balance budget this year, reserves will need to be used next year.
- Potholes are only being patched.
- Charfield development of 120 houses going to appeal.
