#### 02/2020. No. 3. ADOPTION of the MINUTES:

Minutes of the meeting on 8<sup>th</sup> January 2020 were accepted as a true record and duly signed by the chair.

#### 02/2020. No. 4 PUBLIC PARTICIPATION:

Concern was raised over the continuing leakage of sewage from Cromhall pumping station despite repeated complaints to Wessex Water. The problem has been ongoing for many years and poses danger to residents, walkers, animals, livestock and wildlife. Agreed the clerk will contact Wessex Water and report to South Gloucestershire Environmental Health.

A pothole has appeared at Abbotside, the clerk will report. Post meeting reference 1340213.

Stile on OCR10 /10 is damaged, the clerk will report.

There was a query over the minor works at Allotment Row as no lines were painted opposite the houses. The clerk will contact Ward Cllr O'Neil for further information.

A member of the public raised concerns over the lack of defibrillators in the village. The council outlined the rationale for not purchasing defibrillators. The member of public stated willingness to contribute to any purchase.

#### 02/2020. No. 6 ITEMS FOR ACTION

**02/2020 6a.** To consider works to repair a strip of approx. 2ft of worn / lost tarmac to the right-hand side of the driveway over Bibstone Green. to include:

- install a small defining curb,
- replace lost top-soil and grass to the right side of the curbing,
- discuss potential for wooden posts to be installed several feet back from the curbing (in the grass) to prevent cars fully parking on the green.

Council agreed to progress this project paying due regard to legislation around common land. Cllrs Jeffery and Daniel to prepare plans.

**02/2020 6b.** To agree works to low wall to prepare it for possible repairs. Ivy has been removed and wall exposed.

**Resolved** to obtain quotations to undertake repairs to ensure the wall is stable.

**02/2020 6c.** To consider removal of lower limbs from the tree to the centre of the green to address concerns raised from children climbing the tree.

Agreed to ascertain if South Gloucestershire council has a protocol and to check position with insurers.

**02/2020 6d** To consider quotation for new equipment in play area and agree any actions Council considered the safety advice received and reviewed this and a previously received quotation for new play equipment.

**Resolved** to appoint Greenfields to re-position some existing equipment with grass matting and install a 2-berth steel swing with grass matting at a cost of £4485.00 plus VAT.

**02/2020 6e** To consider public consultation on proposed changes to Adult Social Care fees & charges and agree any actions.

South Gloucestershire Council is considering making potential changes to the charges paid by people newly accessing the care system, who fully fund their own social care in the district and would like the Council to arrange care for them. If approved, the new arrangements would come into effect on 1 June 2020. There are three changes proposed:

- New users of dementia, learning disability and specialist day care would be charged £96.30 per day.
- New purchasers of community-based services would be charged a £295 one-off arrangement fee and an annual charge of £75.
- Service users may also become eligible for a £295 fee if they decide to change providers (and ask the Council to arrange it) for a reason not related to their care needs.
